

## Crystal Lake Service League Local Scholarships Including the Legacy Scholarship Honoring Distinguished SL Member Charlotte Shade Fall 2023/Spring 2024

Crystal Lake Service League Scholarships are non-renewable and vary from \$1,000 - \$3,000. Financial Need is a top criteria, but volunteerism and community service are also considered. The students must be attending a 2- or 4-year university. The Legacy Scholarship recipient will be awarded to a high school senior demonstrating academic achievement, a commitment to learning, leadership among peers, and dedication to community service. The Service League will award a scholarship in the amount of \$10,000 to a full-time first-year student entering their college or university in the Fall immediately following high school graduation.

The scholarship funds will be paid directly to the recipient's school after graduation. The Legacy Scholarship will be paid over four semesters unless other arrangements are agreed to in advance. Grants will be limited to Baccalaureate degree institutions. Scholarship money may be applied to tuition, books and/or school fees - this varies by institution, so please check with your school of interest.

All of the following is to be submitted no later than April 3, 2023: Applications that do not include all of the requested items below will not be considered:

- One completed application form submitted to HS career counselor including essay
- One letter of recommendation
- Transcript of academic achievement
- SAR documentation (Student Aid Report that can be downloaded after filling out FAFSA forms).
